RESOLVED, to approve the following Ordinance:

ORDINANCE NO. 3

**AN ORDINANCE IMPOSING IMPRISONMENT AND PENALTY TO DRIVERS OF ALL KINDS OF
VEHICLES WHO SHALL FORCIBLY ENTER IN ALL PROHIBITED ROADS BEARING THE SIGN
"CLOSE ROAD, DO NOT ENTER" IN THIS MUNICIPALITY**

SECTION I. Drivers of all kinds of Vehicles are strictly prohibited
to enter in all roads bearing the sign "CLOSE ROAD, DO NOT ENTER" in this
municipality;

SECTION 2. Violation of this Ordinance or parts thereof, shall be fined the amount of ₱200.00 to ₱500.00 or an imprisonment of 10 30 days of both such fine and imprisonment at the discretion of the court;

SECTION 3. Ordinance or Ordinances inconsistent with the provision of this Ordinance are hereby repealed or modified accordingly;

SECTION 4. This Ordinance shall take effect ten (10) days after its passage;

RESOLVED, FURTHER, that copies of this Ordinance be furnished, the Provincial Treasurer, Calapan, Oriental Mindoro for review and approval.
