EARNESTLY REQUESTING HIS EXCELLENCY BENIGNO C. AQUINO, III, PRESIDENT, REPUBLIC OF THE PHILIPPINES TO CONTINUE THE POVERTY ALLEVIATION PROGRAM OF THE NATIONAL GOVERNMENT THROUGH THE PANTAWID PAMILYANG PILIPINO PROGRAM (4Ps) FOR THE INTEREST AND WELFARE OF THE POOR FILIPINO FAMILIES

"WHEREAS, the Pantawid Pamilyang Pilipino Program (4Ps) is a poverty reduction strategy of the national government that provides grants to extremely poor households to improve their health, nutrition and education particularly of children aged 0-14;

"WHEREAS, the Municipality of Bulalacao, Province of Oriental Mindoro is a Pro-Poor Municipality pursuant to Executive Order No. 370 and whose population is composed of approximately twenty percent hanunuo mangyans who could hardly cope-up with their basic needs;

"WHEREAS, Bulalacao, Oriental Mindoro was lucky to be included among the beneficiaries of 4Ps for it provides those poor families cash assistance to sustain their basic needs including medicines and basic education;

"WHEREAS, it is sad to learn that at present, 4Ps beneficiaries have not yet received their allotments and that, they are afraid that this program will be suspended by the present Administration;


