**RESOLUTION REITERATING THE REQUEST OF THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO TO THE HONORABLE HERMOGENES EBDANE, SECRETARY, DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) FOR THE IMMEDIATE RELEASE OF FUNDS AND IMPLEMENTATION OF CONCRETING OF NATIONAL ROAD FROM MANSALAY BOUNDARY IN ORIENTAL MINDORO TO THE PROVINCE OF OCCIDENTAL MINDORO**

**"WHEREAS,** after so many years, it is glad to see that passenger jeepneys and other kinds of vehicles are now traversing along the national road from Roxas, Oriental Mindoro to San Jose, Occidental Mindoro facilitating the movements of people and shipment of goods from both provinces;
