and conditions as may be agreed upon by both parties;



MEMORANDUM OF AGREEMENT

KNOWN ALL MEN BY THESE PRESENTS:

This AGREEMENT is entered into and executed by and between:

The **PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO (PGOM)**, a local government unit created and existing under and by virtue of the laws of the Republic of the Philippines, with office address at the Provincial Capitol Complex, Barangay Camilmil, Calapan City, Oriental Mindoro, and herein represented by **GOVERNOR HUMERLITO A. DOLOR, MPA, Ph.D.**, hereinafter referred to as the "FIRST PARTY,"

- and -

The **LOCAL GOVERNMENT UNIT OF BULALACAO**, a local government unit created and existing under by the virtue of the Laws of the Republic of the Philippines, with office address at Barangay Poblacion, Bulalacao, Oriental Mindoro, and herein represented by **MUNICIPAL MAYOR LUMELITO M. CABAGAY** to as the "SECOND PARTY."

- WITNESSETH -

WHEREAS, the FIRST PARTY, the Local Government Unit of Bulalacao, Oriental Mindoro, is implementing sustainable fisheries management and development program through technical activities and providing fishery and agricultural programs, activities, and projects to assist and support the livelihood of the barangay constituents.

WHEREAS, SECOND PARTY strengthens and promotes projects that will enrich the technical and financial capabilities of their local fisherfolk.

WHEREAS, the SECOND PARTY sought fishery intervention support from the FIRST PARTY to support their local fisherfolk associations through the provision of the SEAWEED SEEDLING.

WHEREAS, the FIRST PARTY intends to ameliorate the ill effects of the high cost of fishery inputs in the province and an additional source of income for fisherfolk beneficiaries.

NOW, THEREFORE, for and in consideration of the above premises, and of the mutual covenants and stipulations hereinafter set forth, the parties hereto agree to enter into this Memorandum of Agreement under the following terms and conditions:

The **FIRST PARTY** shall:

1. Provide financial assistance for the provision of seaweed seedling amounting to Seventy Thousand Pesos (Php70,000.00) to Local Government Unit of Bulalacao to be used by the seaweed farmers in the locality;

2. Ensure the provision of the seaweed seedlings indicated in the herein attached request prepared by the Municipal Agriculture Office as identified by as the SECOND PARTY;
3. Provide a focal person who will monitor the status of the project implementation;
4. Monitor, inspect, evaluate, and document project activities and identify alternative courses of action to address technical problems met, if any, during the implementation of the project;
5. Monitor, inspect, evaluate, and verify financial records and reports; and
6. Institute necessary action to recover the financial assistance should there be a violation of the second party to the provisions of this agreement.

The SECOND PARTY shall:

1. Ensure that financial assistance received are used according to the provisions stipulated in this agreement unless otherwise revoked with acknowledgment from all parties involved;
2. Ensure that the identified recipient shall provide to the FIRST PARTY a monthly production report per harvest and monitoring report per surveillance penetrated;
3. Allow the FIRST PARTY to monitor and collect necessary data/information when required;
4. Assist FIRST PARTY in the baseline data gathering for the project and in final data gathering to evaluate the outcomes and impacts of the project to the beneficiaries;
5. Submit Quarterly Fund Utilization Report to the Provincial Accounting Office, through the Provincial Agriculturist's Office (PAgO);
6. Submit liquidation report with supporting documents such as official receipt and other related documents to PGOM after the completion of the project;

OTHER CONDITIONS

1. This Agreement shall take effect upon signing hereof and shall remain in force for a period of two (2) years, unless otherwise extended or sooner terminated upon mutual consultation and written agreement of both parties.
2. The FIRST PARTY has the right to blacklist the SECOND PARTY and not be eligible to receive any assistance from the FIRST PARTY if the SECOND PARTY violates the agreement contained herein.
3. The FIRST PARTY has the power to file legal action in court whether it is administrative, civil, or criminal in accordance with existing laws during the time

- Any changes, modifications, and alterations to the foregoing provisions of this agreement shall only be made upon mutual consultation and agreement of all parties concerned.

EFFECTIVITY

This Memorandum of Agreement shall take effect immediately upon signing of the parties hereto and shall remain in force for the duration of the project unless sooner terminated by PGOM for any, but not limited to the following:

- Failure of LOCAL GOVERNMENT UNIT OF BULALACAO to submit the required progress reports within the prescribed period; and
- Any violation of the condition that, as determined by PGOM, will prejudice the successful completion of the project.
