RESOLUTION CONCURRING THE APPOINTMENT OF ENGR. DIANA C. DE GUZMAN AS MUNICIPAL ENGINEER UNDER PERMANENT STATUS IN THE MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO

“WHEREAS, Engr. Diana C. de Guzman was appointed as Municipal Engineer under permanent status by the Municipal Mayor, Hon. Ernilo C. Villas on February 10, 2020;

“WHEREAS, the appointment of Engr. de Guzman was submitted to the Office of the Sangguniang Bayan on February 13, 2020 for concurrence pursuant to Section 443 (d) of Republic Act 7160 otherwise known as the Local Government Code of 1991 which provides that heads of departments and offices shall be appointed by the Municipal Mayor with concurrence of the majority of all the sangguniang bayan members subject to civil service law, rules and regulations;

“WHEREAS, the appointment of Engr. De Guzman was included in the Calendar of Business during the regular session of the Sanggunian held on February 17, 2020 and was referred to the Committee on Legal Matters and Committee on Good Government for review. Thereafter, on February 19, 2020, a committee hearing was called to deliberate the appointment where the committee recommended to calendar the same in the next regular session under the second reading;

“WHEREAS, the vacant mandatory position of Municipal Engineer needs to be filled-up immediately for the best interest and exigency of service in the engineering office and taking into consideration that Engr. de Guzman met all the requirements specified in the Qualification Standard set by the Civil Service Commission as per deliberation of Personnel Selection Board held on February 5, 2020, this August Body finds it necessary to concur the appointment of Engr. de Guzman as Municipal Engineer;

"WHEREAS, the Sangguniang Bayan of Bulalacao advised the appointee to responsibly attend to her duties and responsibilities as stated in the Local Government Code and reminded that her performance must always be in accordance with Republic Act 6713, also known as "The Code of Conduct and Ethical Standards for Public Officials and Employees". 
