**“WHEREAS**, Section 17 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 states that local government units shall likewise exercise such other powers and discharge such other functions and responsibilities necessary, appropriate, or incidental to efficient and effective provision of basic services and facilities such as health services which include hospitals and other tertiary health services;

**“WHEREAS**, the Municipality of Bulalacao is one of the progressing municipalities in the Province of Oriental Mindoro, it has a municipal government that has a paramount objective to uplift the general health condition of the people by providing better medical facilities and services;

**“WHEREAS**, the Local Government Unit of Bulalacao has a pending proposal to establish the Regional Health Laboratory Facility of MIMAROPA Region in this municipality where it is committed to donate 1 to 2 hectares of land area for the site construction which will be located on the immediate lot adjacent to the newly constructed Bulalacao Community Hospital which is also proposed to be converted into a regional hospital because of its advantageous reasons of having strategic midpoint location and more accessible to all the provinces of the region;


